

Helicopter Report August



Responding to a dead elephant found on Olare Orok Conservancy

Narrative:

This month we have flown the helicopter to help elephants and people in conflict, treat wounded elephants, deploy rangers to a bush fire, deploy rangers to an elephant carcass, remove buffalos from Green Park in Naivasha, search for a snared lion, monitor the collared elephants and respond to elephant collar alerts.

The online fundraising has continued to slow down with no new donations in August. On the 11th of August I met with Sue Rodgers who Gordy Church introduced to MEP. Sue Purchased the MD 530F Helicopter for the Lewa Wildlife Conservancy. After my presentation we went for a short flight to the Southern most outpost of the Mara Conservancy, on the Kenya Tanzania border. We hope that Sue will support helicopter operations.

We have sighted the hanger on the Tracks Trust property where there is a large open area of about 300 meters long. Tracks Trust has applied for the addition to the current NEMA license. The foundation pit will start in September. In the interest of speed of construction we have requested a quote from Steel Structures Limited with our specifications for an all-metal hanger and it came to approximately 13,000USD. With the budget of 15,000USD we would not have sufficient funds for the concrete work. We may opt to have faro cement walls to bring down the cost of the walls. We will continue preparing the foundation while we make the final decision on the design of the hanger and fuel store.

Partners MEP and Karen Blixen Camp Trust are developing a Memorandum of Understanding for the use of the helicopter.

MEP hopes to develop a partnership with DSWT and with Sue Rodgers. We are developing more cost centers accounts for flying to ensure accurate allocation of funding. There have been several situations where a single flight covers several purposes so this will need to be developed further.


