The Mara Elephant Project: Because of the international demand for ivory and increasing human activity, elephants in East Africa are prime targets for poachers & are being killed as a result of human/elephant conflict. Sidekick is supporting scientific and educational efforts coupled with direct anti-poaching intervention and field work to stop this brutal practice and to mitigate human/elephant conflict.

Intushield: intuShield is a product designed to protect medical staff during the intubation of COVID-19 critical patients. This product is intended to help shield the frontline during the high exposure process of ventilator insertion. Sidekick partnered with the manufacturer of intuShield to facilitate the donation of shields to smaller community hospitals and clinics that lack the necessary resources to purchase this additional layer of protection. In 2020, 10 shields were donated to 5 hospitals and clinics throughout the country.
